

EVIDENCE BASED EDUCATION POLICY STEPS TO EQUITY IN EDUCATION

EUNEC is the **European Network of Education Councils**. Its members advise the governments of their countries on education and training. EUNEC aims to discuss the findings and recommendations of all European projects in education and training, to determine standpoints and to formulate statements on these issues. EUNEC wants to disseminate these statements pro-actively towards the European Commission, relevant DGs and other actors at European level, and to promote action by EUNEC's members and participants at national level. EUNEC also has the objective that the councils should put internationalisation, mobility and Europeanization high on the national agenda, that they should recommend and support a European policy in education and training towards all relevant stakeholders: ministry of education (and employment), sectoral and branch organisations, providers and other actors.

In 2007 EUNEC is **subsidized** as **European Association acting at European level in the field of education** (Call for proposals DG EAC NO. 26/06). This seminar is organised with the support of this grant. This conference takes place in Lisbon in the context of the **Portuguese presidency** of the European Union. EUNEC will be their host on Monday evening. The Conselho Nacional de Educação organises this event together with the EUNEC secretariat.

The Executive Committee of EUNEC decided to link two current European education issues during this conference. On Monday we will deal with the theme of '**Evidence based education policy**'. The theme was elaborated during a symposium in Frankfurt in March 2007 and the European Commission plans a communication on this issue in autumn 2007. EUNEC wants to get a better view on the content of this concept and to examine the role of education councils on this theme. On Tuesday and Wednesday we will exchange ideas on the issue of **equity in education**, based on research by the OECD. The OECD will present the results of their study, the European Commission will explain its point of view and we will discuss how education councils can move the equity in education agenda forward. We also foresee time for a presentation of examples of good practice.

Steps to Equity in Education

The conference will discuss the outcomes of the OECD thematic review 'No More Failures – Ten Steps to Equity in Education' (foreseen for September 2007) and examine a set of policy levers focused on fair and inclusive design, practices and resources. It will discuss key issues for equity in education, such as early childhood interventions, school choice or secondary education structures, measures to reduce dropout rates, financial or strategic policies countries have adopted or may envisage putting in place to enhance equity in their education systems. The conference will debate how to raise policy awareness of equity in education issues and how policies for equity in education can be best supported.

The Equity in Education Thematic Review of the OECD aims to draw policy lessons on how to improve equity in education by looking at specific equity challenges countries are facing. These include equity in compulsory education and variability in results across students and schools, early school leaving, different educational pathways and how they might be having an impact on equity, and the integration of migrants and minorities in the education system. Ten countries were participating in the activity - Belgium (Flemish region), Finland, France, Hungary, Norway, the Russian Federation, Slovenia, Spain, Sweden, and Switzerland. Each participating country prepared an analytical report on equity in education. Additionally, five of the countries (Finland, Hungary, Norway, Spain and Sweden) opted for the full-scale thematic review strand, which included a country visit by an OECD review team and the preparation of a Country Note. All strands of work feed into the preparation of a final comparative report.

Using evidence from the OECD research to discuss key recommendations on equity in education and to help education councils to advise their governments is a concrete application of the subject of the first day (evidence based policy).
