# ANNUAL REPORT ABOUT THE SPANISH EDUCATION SYSTEM




Every year, the Council will make and then publish a report about the situation of the Spanish Education System. This report should collect all comprehensive available data, including the possible violence events in the education community (Fortunately, Spain, up to now, don't know situations of extreme violence in the schools).

Moreover, in this annual report, the Council has to inform the measures taken by the Educational Administrations (Autonomous Communities and Ministry of Education) relating to the prevention of the violence and promoting the egality between men and women. Article 30. Emission of the reports

1. In every topic analysed by the Plenary Assembly of the Council, the preliminary report has to be elaborated by the Permanent Committee.

2. This preliminary report must be distributed to all the 107 Councillors, at least, ten days before the meeting of the Plenary Assembly.

3. The Councillors (usually two) designated by the Permanent Committee will explain to the Plenary the contents of the report and communicate the results of the votes.



### CREATION PROCESS OF THE F CHAPTER: PROPOSALS TO IMPROVE THE SPANISH EDUCATION SYSTEM

1. Request of proposals from the Councillors of the Permanent Committee of the CEE.

2. Meetings with the Councillors to reach agreements.

3. Sending of the consensual proposals to the Permanent Committee.

**4. Meeting of the Permanent Committee** to take into consideration the consensual proposals.

5. Preliminary submission to the General Assembly of the F Chapter of the Report, including the consensual proposals from the Permanent Committee.

6. Request for new proposals to the Councillors not directly represented in the Permanent Committee.

7. Delegation of competences to the two designated Councillors charged upon the management of the process. Their goal is to integrate the new proposals into the previously agreed. To do this they will hold meetings with the Councillors. The **Permanent Committee** must validate the new common proposal.

8. Submission to the General Assembly of both the consensual and non consensual proposals, and the possible amendments to the F Chapter of the Report.

**9. General Assembly meeting** to debate and eventually take into consideration the consensual and non consensual proposals, and also the amendments.

#### For the first time in the history of the Spanish Council, the Annual Report has been approved unanimously
