Higher Council for Education, Training and Research An **independent advisory** institution for good governance, sustained development and participative democracy

The Moroccan Law n° 1.14.100 , 16 May 2014 stipulates the missions of the Council

The Higher Council has two main missions:

Opinions, strategic orientations and studies

Issuing Opinions on public policies and national options related to education, vocational training, and research

•Evaluation:

•Contributing to the assessment of public policies and programs in the fields of education, vocational and training research



The process of issuying strategic opinions, orientations and reports

On its own initiative within the scope of its missions.On request /referral of :

✓ The king: reform, evaluation

✓ The gouvernement or parlement : proposals of laws, programmes, projects related to education, training and research...



The scope of its work and production:

✓ All issues related to: education, university training, vocational training and research



Preparing studies and conducting research either on its own initiative or upon the government's request ;

•Carrying out global, sectorial or thematic evaluations of the policies and public programs and publishing their findings ;

Presenting proposals to the government that would contribute to the improvement of the quality of the system of education, vocational training and research;

•Encouraging the policies of enhancing and consolidating the structures of research, and motivating researchers,

Independency from any external pressure ;

- Transparency in its functioning ;
- Commitment for educational rights ;
- Accountability to society.



An institution for strategic thinking on issues related to education, vocational training and research;

- A credible voice on matters related to education, vocational training and research ;
- An institution observing the development of the educational system through evaluation ;
- A mechanism for enhancing social mobilization about the Moroccan school and education.



- In 2014, the Council undertook an evaluation of 13 years of reform of educational system from 2000 to 2013;
- •On the basis of that evaluation the Council has elaborated /
 - ✓ The Strategic Vision 2015-2030 based on three pillars :
 - o Equity
 - Quality
 - Development of the individual and society





The Organs of the Council





Members

In addition to the President, appointed by the King, the Council has **94** members

20 Experts and specialists

appointed by the King from among persons with an established expertise in the fields of education, vocational training and scientific research

23 Members appointed as ex-officio

representing the government, academic and scientific institutions, parliament and educational and vocational training institutions

51 Members

representing unions, educational and administrative executives, students' parents and guardians, teachers, high school and university students, local Council members, civil society, contractors, and bodies most representative of private education and training.



The Commissions of Council

- Commission for Education for all and Accessibility
- Commission for the governance of the system of education and vocational training
- Commission for programs, vocational trainings and pedagogical methods and didactic materials
- Commission for teaching, training and management professions
- Commission for scientific and technical research and innovation
- Commission for social and cultural services and school environment



In addition to Permanent Commissions, the Assembly may create ad hoc commissions which will work on specific issues

The missions of the National Agency for Evaluation

- •Carrying evaluation: global, by sector, by subject or programmes;
- •Focussing on the public policy of the educational system and research;
- Conceiving instruments and tools of evaluation :
- •Aligning its work with the international standards.
