### **EUNEC** at work

#### Report and statements on 'Learning in the digital age'

EUNEC has organized for its members a seminar on 'Learning in the digital age'. The event we hosted by the Greek National Council for Education and took place in Athens on 5-6 May 2014

A full report is now available. Participating councils agreed on common statements on the top

The statements identify recent evolutions with impact on education and training.

First of all, the profile of the learners and their learning opportunities have drastically change Learning is no longer a monopoly of the school as an institution. Learning can be anywhere at any time. Learning is a social activity; new and creative insights are the result of a dialogue be peers and experts, often on the basis of information provided by the internet. ICT enhances opportunities for personalized learning. In this deep shift the central debate on learning goes beyond the mastery of a specific software problem.

Secondly, radical and intrusive changes in the economy and the society impact on education. Learning is at the heart of 21st century knowledge societies.

Thirdly, ICT and new technology can be an answer to the need for cost effective and high quaeducation systems.

The OECD Innovative Learning Project, presented in Athens, describes the following characters cs of adequate learning that should all be integrated in the learning environment:

- make learning central, encourage engagement and stimulate learners to understand them ves (self-regulation)
- ensure that learning is social and collaborative
- be highly attuned to learners motivations and emotions
- be sensitive to individual differences in learning pace and prior learning
- be demanding for each learner without excessive overload
- , use assessment consistent with its aims with a strong emphasis on formative feedback
- promote horizontal connectedness across activities in the school and out-of-school.

Challenges for education systems have to do with content and curriculum, with innovative schorganization, with infrastructure and resources and with teachers' competences to develop in learning environments.

#### **The new European Commission**


On 10 September 2014, president-elect Juncker unveiled his team and the new shape of the next European Commission.



#### **Results of TALIS 2013**

The OECD Teaching and Learning International Survey (TALIS), first launched in 2008, asks teachers and schools about their working conditions and their learning environments.

The results of the 2013 edition show that more than nine out of ten teachers are satisfied with their jobs and nearly eight in ten would choose the teaching profession again. But fewer than one in three teachers believe teaching is a valued profession in society. Those countries where teachers feel valued tend to perform better in PISA.



#### The Italian Presidency of the EU

From 1 July 2014, the three presidencies of the European Council for the next 18 months (Italy, Latvia and Luxembourg) have one ultimate goal: fully overcoming the economic crisis and returning to a job rich growth, as well as seizing the opportunities of the digital economy.
