The Belgian Presidency of the EU: EUNEC takes part

rom the 1st of July until the 31 of December 2010 it is Belgium's turn to take up the Presidency of the Council of the EU. This is a real challenge.

In the programme of the Belgian Presidency we read that, in the field of education and training, the Council will adopt conclusions on education in the field of sustainable development, within the framework of the Europe 2020 Strategy and the need for a green, sustainable and skills-based economy.

The Presidency will continue the work embarked upon by previous Presidencies concerning the strengthening of European cooperation in the domain of school education, with particular attention to the problems associated with the failure to complete schooling, and to core skills, as well as to the role of education and training in social inclusion.

The Council will adopt guidelines with a view to setting up a new work programme on the education and training of professionals until 2020. At the Informal Meeting of Ministers in Bruges, the candidate countries and countries of the EEA will be invited to join this work programme. Draft conclusions will be submitted to the Council.

The Belgian Presidency will also work towards modernising higher education in Europe and on the interaction between higher education, research and innovation.

Focus on the Cyprus Education Council

n an effort to respond to the numerous socioeconomic, political and cultural changes that have affected the Cyprus education system, the Government of the Republic of Cyprus has initiated an ambitious Educational Reform Programme, inviting dialogue among all stakeholders. The ambition is to turn into reality the vision of modernizing the educational system. The main objective is to create a democratic and student-focused educational system, which includes all students irrespective of social, racial or ethnic background, gender, physical or mental ability ad offers high quality education to each student.

he Cyprus Education Council was set up as part of this process for the reform of the education system. The Council is chaired by the Minister of Education and Culture, and includes the Ministry's Permanent Secretary, the President of the Education Committee of the Parliament and representatives of the major political parties. Its role is advisory and its major priority is the enhancement of the implementation of the education reform at all levels and in every aspect of the education system.

The Education Council coordinates and monitors the dialogue among all the major stakeholders involved in education.

urthermore, it is responsible for setting the priorities for the dialogue, establishing technical committees or appointing experts for the preparation of reports and studies on various issues within the framework of the educational reform and the work of two subcouncils that have also been established: the Primary and Secondary Education Council and the Higher Education Council.

The Council submits recommendations to the Council of Ministers, for the formulation of educational policy, in the light of the outcomes of the work done by the technical committees and the two sub-councils.

The study on education councils in the EU: the Spanish case study

he study on education councils, commissioned by EUNEC and executed by the Public Management Institute (Catholic University of Louvain) under the supervision of Professor Marleen Brans, is reaching its final stage.

The research team has established factsheets describing education councils throughout Europe. Apart from those fact sheets, the researchers are completing six in-depth

case studies: the Flemish, Greek, Portuguese, Dutch, Estonian and Spanish Education Councils.

The research team is now finalising the description of the CEE, the Consejo Escolar del Estado, the Spanish National Education Council. In order to collect valid data for the description, professor Marleen Brans travelled to Madrid to do in depth interviews with representatives of the Council.

In r Antonio Frias del Val, representative of the CEE at the EUNEC executive committee, kindly took up the organization of the interviews.

The final report will be published within few months and will be presented at the EUNEC anniversary conference on 1, 2 and 3 December in Brussels.

n 14 June 2010, the European Commission invited organisations and institutions interested in school policy to discuss future actions in the field, in particular on the issue of early school leaving (Meeting school education. Stakeholder platform).

UNEC assisted the seminar 'Breaking the cycle of disadvantage. Strategies for equality and inclusion in and through education and training', organised by the European Commission, with a presentation by Professor Ides Nicaise. This seminar is a preparation for the conference on social inclusion that will be organized under the Belgian Presidency in Ghent on 28-29 September 2010.

inally, EUNEC participated at the conference on 'Youth on the move' and VET, in Brussels, on 22 June 2010. The conference was organized in cooperation with several European regio's, and informed about European initiatives in the field of skill development and mobility. Two of the Flagship Initiatives of the Europe 2020 Strategy were discussed: 'Youth on the move' and 'New skills for new jobs'.

t the Executive Committee meeting of I June in Limassol, Cyprus, the EUNEC secretariat presented a new overview of recent developments in policy lines in education and training in Europe.

Lots of information about the evaluation of the Lisbon Strategy and the new Europe 2020 Strategy: results of the public consultation, in which EUNEC participated; information about the Council Conclusions on the strategy for jobs and

growth, insisting on the headline targets.

Ir urthermore, the document provides information on new policy lines in specific fields within education and training: new skills for new jobs, the social dimension of education and training, the Bologna Process, European Qualifications Framework.

The document also gives an overview of recent international studies and reports on a variety of subjects: skills needs, creativity, key competences, ICT indicators, validation of non-formal and informal learning.

Relevant developments in other policy domains (culture, youth) are followed up.
